APPROVING SB RESOLUTION NO. 55, S-2024 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED "APPROVING THE MUNICIPAL DEVELOPMENT PROJECTS WORTH OF FIFTY-ONE MILLION, ONE HUNDRED FORTY-THREE THOUSAND, FOUR HUNDRED FIFTY-SEVEN PESOS AND FORTY CENTAVOS (P51,143,457.40) FUNDED BY THE MUNICIPAL DEVELOPMENT FUND (MDF) FY 2025 OF THE MUNICIPALITY OF BANI, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan submitted its Resolution No. 55, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following finding:

- 1. The development fund amounting to Php51,143,457.40, which is allocated for development projects and debt servicing, is equivalent to 20% of the municipality's NTA amounting to Php 255,717,287.00 for CY 2025. This is in accordance with Section 287 of RA 7160; and
- 2. The identified development programs/projects to be funded by the 20% development fund, emanated from the Local Development Council thru MDC Resolution No. 2024-08 on September 19, 2024 and was favorably acted upon by the Sangguniang Bayan on November 4, 2024 thru SB Resolution No. 55, S-2024, which is also the subject under review, are based on the DILG-DOF-DBM Joint Memorandum Circular No. 1 dated

November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects).

WHEREAS, the Local Government Unit shall specify the Other Development Programs and Projects in accordance with the above-cited guidelines;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bani, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was–

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 55, S-2024 of the Sangguniang Bayan of Bani, Pangasinan, entitled "Approving the Municipal Development Projects worth of Fifty-One Million, One Hundred Forty-Three Thousand, Four Hundred Fifty-Seven Pesos and Forty Centavos (P51,143,457.40) funded by the Municipal Development Fund (MDF) FY 2025 of the Municipality of Bani, Pangasinan";
