RESOLUTION NO. 349-2025

APPROVING SB RESOLUTION NO. 56, S-2024 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED "APPROVING THE ANNUAL INVESTMENT PROGRAM (AIP) FY 2025 OF THE MUNICIPALITY OF BANI, PANGASINAN AMOUNTING TO TWO HUNDRED EIGHTY-SIX MILLION, NINE HUNDRED TWO THOUSAND, ONE HUNDRED SIXTY-FIVE PESOS AND 58/100 (P286,902,165.58) FUNDED BY THE GENERAL FUND AND MUNICIPAL DEVELOPMENT FUND (MDF) BOTH FY 2025"

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan submitted its Resolution No. 56, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- 1. In pursuance to Sections 106, 109, and 114 of the Local Government Code of 1991, the Local Development Council of Bani, Pangasinan has formulated the municipality's Annual Investment Program for Calendar Year 2025, which was endorsed to the Sangguniang Bayan for approval through MDC Resolution No. 2024-08 dated September 19, 2024;
- 2. The AIP of the municipality is in accordance with the Budget Operations Manual (BOM) for LGUs, 2023 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated March 8, 2007 DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01 dated July

- 23, 2015 as to format and content. The AIP of Bani, Pangasinan was formulated following the prescribed AIP Summary Form categorized into general public, social, economic, and other services. It likewise covers: (a) all the regular budgetary items for the operations of the different municipal offices broken down into PS, MOOE, Financial Expenses, and Capital Outlay; (b) the priority development programs/projects and those to be funded by the 20% development fund, and; (c) disaster risk reduction management programs/projects/activities of the municipality. It further includes the following: 1) Gender and Development Plan and Budget, Peace and Order and Public Safety Program (including PPAs to address Problems on Illegal Drugs), Local Nutrition Action Plan, and Annual Cultural Development Plan, Local Climate Change Action Plan, Local Youth Development Plan, Annual Procurement Plan, and; 2) list of programs/projects/activities for the Local Council for Protection of Children, Senior Citizens and Persons with Disabilities, PPAs to combat Acquired Immune Deficiency Syndrome;
- 3. The proposed AIP has a total investment requirement of Php286,902,165.58 which will be funded from the municipality's proposed 2025 Annual Budget enacted on November 4, 2024 through Appropriation Ordinance No. 04, Series of 2024 and approved by the Municipal Mayor on December 13, 2024;
- 4. The development fund amounting to Php51,143,457.40, which is allocated for development projects and debt servicing, is equivalent to 20% of the municipality's NTA amounting to Php 255,717,287.00 for CY 2025. This is in accordance with Section 287 of RA 7160. The identified development programs/projects to be funded by the 20% development fund, emanated from the Local Development Council thru MDC Resolution No. 2024-08 on September 19, 2024 and was favorably acted upon by the Sangguniang Bayan on November 4, 2024 thru SB Resolution No. 55-S.2024, which is also the subject under review, are based on the DILG-DOF-DBM Joint Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects). It is recommended however, that the "Other Development Programs and Projects" shall be specified and in accordance with the above-cited guidelines;
- 5. The attached Disaster Risk Reduction and Management Programs/Projects/Activities in preparation for and to mitigate the impact of disasters to be funded by the 5% Local Disaster Risk Reduction and Management Fund of the municipality amounting to Php14,073,568.45, conforms to Section 21 of RA 10121. The programs/projects to be funded from the 70% of the LDRRMF in the amount of Php9,851,497.92 are based on the NDRRMC-DBM and DILG Joint Memo Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of Local Disaster Risk

Reduction and Management Fund) and the 30% amounting to Php4,222,070.53 is allocated for Quick Response Fund (QRF). It is respectfully recommended that the LDRRM Plan be submitted to the OCD for review as provided under item no. 2.2.12 of the Department of Budget and Management (DBM) – Local Budget Memorandum (LBM) No.77 dated May 15, 2018 and DBM Local Budget Memorandum Circular No. 82 dated June 14, 2021.

- 6. The LGU has also identified programs/projects/activities responsive to climate change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015; and
- 7. The Gender and Development Plan of the municipality has been reviewed by the Department of the Interior and Local Government (DILG) and was found to be fully compliant in form and contents with the provisions of the Joint Memo Circular of 2016-01: Amendments to JMC 2013-01 re: Guidelines on Localization of the Magna Carta of Women as per attached Certificate of Review and Endorsement of the DILG dated March 27, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bani, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 56, S-2024 of the Sangguniang Bayan of Bani, Pangasinan, entitled "Approving the Annual Investment Program (AIP) FY 2025 of the Municipality of Bani, Pangasinan amounting to Two Hundred Eighty-Six Million, Nine Hundred Two Thousand, One Hundred Sixty-Five Pesos and 58/100 (P286,902,165.58) funded by the General Fund and Municipal Development Fund (MDF) both FY 2025";
