**RESOLUTION NO. 356-2025**

**APPROVING RESOLUTION NO. 04-2025 OF THE SANGGUNIANG BAYAN OF LABRADOR, PANGASINAN, ENTITLED “APPROVING SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 1 FOR CY 2025 OF THE MUNICIPALITY OF LABRADOR, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Labrador, Pangasinan submitted its Resolution No. 04-2025 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Labrador, Pangasinan prepared their Supplemental Annual Investment Program (SIP) No. 1 for CY 2025. This was endorsed by the Council, through MDC Resolution No. 001-S-2025 dated January 23, 2025, to the Sangguniang Bayan for approval. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;
2. Said Supplemental AIP, which has a total investment requirement of P14,200,000.00, covers the augmentation of funds for Maintenance and Other Operating Expenses (MOOE) and Capital Outlay (CO), and implementation of various infrastructure projects of the LGU; and

3. Funding for the implementation of the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 1, FY 2025, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 01-2025 dated January 27, 2025, and approved by the Municipal Mayor on January 30, 2025.




