RESOLUTION NO. 362-2025

DECLARING ORDINANCE NO. 2024-05 OF THE SANGGUNIANG BAYAN OF SISON, PANGASINAN, ENTITLED "AN ORDINANCE GRANTING CASH INCENTIVES TO EXAMINEES WHO EXCELLED IN EITHER THE BAR OR BOARD EXAMINATION AND DECLARED TOPNOTCHERS BY EITHER THE SUPREME COURT OF THE PHILIPPINES OR THE PROFESSIONAL REGULATIONS COMMISSION, RESPECTIVELY, AS WELL AS TO THE HONOR GRADUATES IN COLLEGE, PROVIDING FUNDS THEREFOR AND FOR OTHER PURPOSES IN THE MUNICIPALITY OF SISON, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Sison, Pangasinan submitted its Municipal Ordinance No. 2024-05 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16 & 447 (a) (2) (ii) (5) of R.A. No. 7160;

WHEREAS, the Local Government Unit in coordination with the Municipal Local Finance Committee shall provide an appropriation in the supplemental budget to implement the subject ordinance;
