RESOLUTION NO. 365-2025

APPROVING MUNICIPAL RESOLUTION NO. 130-2024 OF THE SANGGUNIANG BAYAN OF NATIVIDAD, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 03 FOR CY 2024 OF THE MUNICIPALITY OF NATIVIDAD, PANGASINAN AMOUNTING TO FOUR MILLION NINE HUNDRED FIFTY ONE THOUSAND SEVEN HUNDRED SEVENTY FOUR PESOS AND TWENTY SIX CENTAVOS (P4,951,774.26)”

WHEREAS, the Sangguniang Bayan of Natividad, Pangasinan submitted its Resolution No. 130-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Natividad, Pangasinan has identified items in their Supplemental Annual Investment Program (SAIP) No. 03 for CY 2024. This was endorsed by the Municipal Development Council to the Sangguniang Bayan on December 5, 2024 through Executive Committee Resolution No. 04-2024;
2. The SAIP No. 03 of the municipality covers fund augmentation for Personal Services (Granting of Service Recognition Incentive (SRI) to Qualified Officials and Employees of LGU Natividad), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay of some offices in

the LGU of Natividad and the implementation of disaster risk reduction programs and projects of the municipality. It is recommended, however, that the LGU shall use the new prescribed AIP Summary Form in their succeeding AIPs/SIPs in accordance with Local Budget Memorandum No. 87 dated June 9, 2023;

3. Likewise, SAIP No. 03 also covers the implementation of programs, projects and activities (Livelihood Projects for Tobacco Farmers) to be funded from the municipality's share from the FY 2020 Burley and Native Tobacco Excise Tax Collection. Said project is consistent with Local Budget Memorandum No. 86 dated December 14, 2022; and
4. Funding support for the proposed SAIP, with a total investment requirement of PhP4,951,774.26 is embodied in the municipality's Supplemental Budget No. 03-2024, which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 04-2024 on December 16, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Natividad, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—


