RESOLUTION NO. 366-2025

DECLARING THE SUPPLEMENTAL BUDGET NO. 03 FOR CALENDAR YEAR 2024 OF NATIVIDAD, PANGASINAN, INVOLVING A TOTAL APPROPRIATION OF P4,951,774.26, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Natividad, Pangasinan submitted its Supplemental Budget No. 3 for Calendar Year 2024 involving total appropriations of P4,951,774.26, which was enacted on December 16, 2024 through Appropriation Ordinance No. 04-2024;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

- That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417 (a) of its IRR, as amended by Administrative Order No. 47 dated April 12, 1993;
- 2. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its Implementing Rules and Regulations;

- That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2024 Annual Investment Program of the municipality and its supplements thereto formulated pursuant to DILG-NEDA-DBM-DOF- Joint Memorandum Circular No. 1, Series of 2017 dated March 8, 2007;
- 4. That the grant of Service Recognition Incentive (SRI) to municipal officials, regular and casual employees shall be in accordance with the provisions of Budget Circular No. 2024-2 of the Department of Budget and Management, dated December 13, 2024;
- That the reversion of savings shall be in accordance with the provisions of Section 336 of R.A. No. 7160 (Use of Appropriated Funds and Savings);
- That the grant of Gratuity Pay for FY 2024 to Contract of Service (COS) and Job Order (JO) shall be in accordance with the provisions of Budget Circular No. 2024 - 8 dated December 20, 2024 of the Department of Budget and Management; and
- That the utilization of appropriation from FY 2020 shares of the Municipality from the Burley and Native Tobacco Excise Tax Collections under R.A. No. 8240 shall be subject to the provisions of Local Budget Memorandum No. 86 dated December 14, 2022.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was-

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety Supplemental Budget No. 3 for Calendar Year 2024 of Natividad, Pangasinan;
