PROVINCIAL RESOLUTION NO. 376-2025

AUTHORIZING THE PROVINCIAL GOVERNOR, HON. RAMON V. GUICO III, TO APPLY TO THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) THE RENEWAL OF REVOCABLE PERMITS OVER PARCELS OF FORESHORE LAND SITUATED IN BRGYS. POBLACION AND LIBSONG WEST, LINGAYEN, PANGASINAN, FOR THE CONTINUOUS EXPANSION AND DEVELOPMENT OF CAPITOL GROUNDS

WHEREAS, the Sangguniang Panlalawigan enacted Provincial Resolution No. 41-2024, dated January 15, 2024, entitled “Authorizing the Provincial Governor, Honorable Ramon V. Guico III, to enter into and sign Appropriate Tenurial Instruments and/or Contracts with the Department of Environment and Natural Resources (DENR) for future expansion and development of Capitol Grounds”;

WHEREAS, the present undertaking is in line with DENR Administrative Order No. 2004-24 issued on August 24, 2004, known as the “Revised Rules and Regulations Governing the Administration and Management of Foreshore Lands”, which provides pertinent rules and regulations in order to rationalize and regulate the utilization and occupation of foreshore lands;

WHEREAS, Section 1 of the same Administrative Order provides for policies and objectives to be undertaken by the DENR, as follows: “*a. Pursue the government's policy to tap all resources to generate economic opportunities and promote social equity; b. Promote the sustainable use of our country's foreshore/marshy lands through effective and efficient management schemes and strategies; c. Institutionalize a cohesive partnership among the national government agencies, local government units, and foreshore leaseholders for the conservation and maintenance of an ecologically-balanced environment without compromising the financial benefits to be derived from user's fees and other similar fees; d. Provide an accepted scheme to ensure access to the sea and water bodies for emergency purposes and benefit of the general public; and, e. Establish an automated system of foreshore lands related data/information*”;

WHEREAS, the Provincial Government of Pangasinan intends to develop/utilize parcels of foreshore land for the continuous expansion and development of Capitol grounds, covering the area of 8,268 sq. m located in Brgy. Poblacion, and 86,409 sq. m. located in Brgys. Poblacion and Libsong West;

WHEREAS, on April 23, 2024, the DENR granted to the Province of Pangasinan, represented by Gov. Ramon V. Guico III, the following revocable permits for the temporary occupation and use of portion of foreshore land for the expansion and development of Capitol grounds:

WHEREAS, the Revocable Permits issued to the Province is set to expire on April 23, 2025, therefore there is a need to apply to DENR for its renewal in order to undertake the continuous expansion and development of Capitol grounds, in accord with the pertinent laws, rules and regulations relative to the proper utilization and occupation of foreshore lands;

WHEREAS, Section 465 (b) (1) (vi) of the Republic Act No. 7160 provides that the Provincial Governor, as the Local Chief Executive, shall represent the province in all its business transactions and sign on its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;

NOW, THEREFORE, on motion of SP Member Vici M. Ventanilla, duly seconded, it was -


RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Hon. Ramon V. Guico III, to apply to the Department of Environment and Natural Resources (DENR) the renewal of revocable permits over parcels of foreshore land situated in Brgys. Poblacion and Libsong West, Lingayen, Pangasinan, for the continuous expansion and development of Capitol grounds;

RESOLVED FINALLY, that copies of this resolution be furnished to the Honorable Governor, Ramon V. Guico III, Province of Pangasinan, and CENRO-Dagupan City, for their information and guidance.
