PROVINCIAL RESOLUTION NO. 378-2025

AUTHORIZING THE HONORABLE GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT – REGIONAL OFFICE I FOR THE IMPLEMENTATION OF THE GOVERNMENT INTERNSHIP PROGRAM (GIP) IN THE PROVINCE OF PANGASINAN

WHEREAS, the national government has been determined in defining its role to help the local government units in the application of policies, programs and projects to generate more jobs for the youth and reduce poverty in the countryside;

WHEREAS, the Government Internship Program (GIP) is a continuing program of the Department of Labor and Employment (DOLE) that aims to provide internship opportunities to poor/indigent and young workers to demonstrate their talents and skills in the field of public service;

WHEREAS, the DOLE-GIP desires to give opportunities for GIP interns to obtain work experience in government agencies and offices at the local and national levels;

WHEREAS, the Provincial Government of Pangasinan is continually supporting the program in cooperation and partnership with DOLE to promote the poor/indigent and young workers' welfare as well as their exposure to public service;

WHEREAS, the proposed agreement between the Provincial Government of Pangasinan and DOLE-Regional Office I is executed to set forth the duties and obligations of the parties in the implementation of the program in the Province of Pangasinan;

WHEREAS, for the above purpose, the Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Governor Ramon V. Guico III, and the Department of Labor and Employment – Regional Office I, represented by Regional Director Exequiel Ronie A. Guzman;

NOW THEREFORE, on motion of SP Member Jerry Agerico B. Rosario, duly seconded, it was -


