PROVINCIAL RESOLUTION NO. 383-2025

AUTHORIZING THE HONORABLE GOVERNOR, RAMON V. GUICO III, TO SIGN THE DEED OF DONATION AND TO RECEIVE ONE (1) UNIT OF NEWBORN SCREENING MACHINE FROM THE DEPARTMENT OF HEALTH ILOCOS CENTER FOR HEALTH DEVELOPMENT

WHEREAS, one of the primordial concerns of the provincial government of Pangasinan is to address health issues and provide medical service needs of the people;

WHEREAS, the Department of Health (DOH), as the principal agency of the government which consistently contributes to the upgrading of medical and health care facilities of local government units, has manifested its desire to further augment its support to the Provincial Government of Pangasinan through the Health Facility Enhancement Program;

WHEREAS, the Province of Pangasinan will be the recipient of one (1) unit of Newborn Screening Machine amounting to P1,395,000.00 from the Department of Health Ilocos Center for Health Development in the form of a donation and hereby expresses its willingness to accept the same;

WHEREAS, this newborn screening machine will be used primarily and effectively by the Province through the Mapandan Community Hospital to cater and respond immediately to the health necessities of the newborn;

WHEREAS, it is to the best interest of the Provincial Government to sign the Deed of Donation and accept the newborn screening machine from the Department of Health Ilocos Center for Health Development to augment the need for specialized medical equipment of the Province;

WHEREAS, local government units are empowered under Section 22 (a) (5) (c) and Section 465 (vi) of RA 7160 to enter into contracts, but such power may be exercised with prior authorization emanating from the Sangguniang Panlalawigan through a resolution/ordinance;


WHEREAS, for the above purpose, a Deed of Donation shall be entered into and signed between the Province of Pangasinan, represented by Governor Ramon V. Guico III, and the Department of Health Ilocos Center for Health Development, represented by its Regional Director, Dr. Paula Paz M. Sydiongco;

NOW, THEREFORE, in view of the foregoing, on motion of SP Member Shiela Marie F. Baniqued, duly seconded, it was –


