RESOLUTION NO. 390-2025

DECLARING ORDINANCE NO. 2024-30 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING CITY ORDINANCE NO. 2019-09, OTHERWISE KNOWN AS THE ALAMINOS CITY SOLO PARENTS WELFARE ORDINANCE, CREATING A SOLO PARENTS' OFFICE, DEFINING ITS FUNCTIONS, PROVIDING FOR ITS PERSONNEL COMPLEMENT AND PROGRAM GUIDELINES, ALLOCATING FUNDS FOR ITS OPERATION AND FOR OTHER PURPOSES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2024-30 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;




