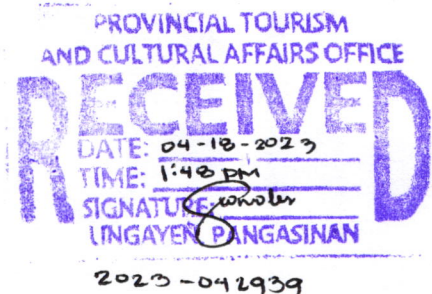

EXECUTIVE ORDER NO. 0031, SERIES OF 2023

AN ORDER CREATING THE TECHNICAL WORKING GROUP (TWG) OF BAKALAN MIXED MARTIAL ARTS, DEFINING ITS DUTIES AND RESPONSIBILITIES, AND FOR OTHER PURPOSES

WHEREAS, it is the policy of the State to promote physical education and encourage sports programs, league competitions, and amateur sports, including training for international competitions, to foster self-discipline, teamwork, and excellence for the development of a healthy and alert citizenry;

WHEREAS, Section 17 paragraph (b) (3) (xii) of the LGC of 1991, mandates the local government unit to exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient provision of the basic services and facilities which includes the tourism development and promotion programs;

WHEREAS, there is a need to create a Technical Working Group of Bakalan Mixed Martial Arts to lead and facilitate the said event.

NOW THEREFORE, I, RAMON V. GUICO III, Governor of the Province of Pangasinan, by virtue of the powers vested in me by law, do hereby create the Technical Working Group and order as follows:

SECTION 1. CREATION. The Bakalan Mixed Martial Arts TWG shall be composed of the following:

SECTION 2. FUNCTIONS. The TWG shall work hand in hand towards the completion of the following duties and responsibilities anent the implementation of the Bakalan Mixed Martial Arts;

- a. To lead and supervise the implementation of the Bakalan Mixed Martial Arts event scheduled on April 28, 2023;
- b. To ensure adherence of the Universal Reality Combat Championship to the terms of agreement with the provincial government;
- c. To mobilize appropriate offices and agencies and to provide necessary logistical requirements and services to said event; and
- d. To perform such other functions as deemed necessary to achieve the goals and objectives of the said event.

SECTION 3. SEPARABILITY CLAUSE. If any provision of the Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

SECTION 4. EFFECTIVITY CLAUSE. This Order shall take effect immediately.
