**EXECUTIVE ORDER NO. 0051, SERIES OF 2023**

**AMENDING THE MEMBERSHIP OF THE PROVINCIAL COUNCIL FOR THE PROTECTION OF CHILDREN IN THE PROVINCE OF PANGASINAN**

**WHEREAS**, Republic Act 4881 known as “An Act Creating A Council For The Protection of Children In Every City And Municipality of The Philippines And For Other Purposes” enacted in 1967 mandated the creation of a Council for the Protection of Children in Cities and Municipalities so that the sacred duty of the state “to assure that every family is helped to bring up their children to make them useful men and women and to see that the proper direction, supervision, and guardianship in the training, education, and other interests of its minor citizens be undertaken by it.

**WHEREAS**, Articles 359 and 360 of the Civil Code of the Philippines provide that the government shall establish Councils for the Protection of Children, taking into account that children are the ones who are most vulnerable to abuse, neglect, and/or exploitation, among others.

**WHEREAS**, Executive Order No. 0012-2021 dated February 9, 2021, has established the Provincial Inter-Agency Committee on Provincial Council for the Protection of Children in the Province of Pangasinan;

**WHEREAS**, the composition of members of the said committee was also identified in the said executive order;

**WHEREAS**, some members of the committee have been reassigned, transferred, resigned, and/or retired from the government service;

**WHEREAS**, there is a need to amend the membership of the said committee;

**NOW, THEREFORE, I, GOVERNOR RAMON V. GUICO III**, by virtue of the powers vested in me by law; ***do hereby amend the membership of the Provincial Council for the Protection of Children*** in the Province of Pangasinan, which shall be composed of the following:


**The PCPC shall have the following functions:**

1. Formulate, develop, coordinate, monitor, and review all local policies, ordinances, plans, programs, and activities which shall promote the best interest and rights of children and ensure mainstreaming in the local development agenda.;
2. Establish, maintain, and update a disaggregated database or local information system on children and their situations.
3. Conduct advocacy activities on the promotion and protection of the rights and welfare of children including the development of information, education, and advocacy materials.
4. Conduct capability-building activities for all stakeholders on children including the barangay -level;
5. Provide assistance to children in need of special protection;
6. Document good practice/son children;
7. Coordinate and consult with the LCPCs, LGU, and other regional, and national authorities with respect to policies and PPAs on children; and
8. Conduct the Child-Friendly Local Governance Audit (CFLGA), through the LCPC Inter-Agency Monitoring Task Force (IMTP), annually;

9. Assist and support the lower level LCPCs on their PPAs for children;
10. Develop a Technical Assistance and Resource Augmentation (TARA) Plan based on the results of the annual LCPC Functionality Assessment and the CFLGA; and
11. Other functions related to its mandate as provided by national laws and policies;
12. Prepare Annual Work and Financial Plan (AWFP) for children for incorporation in the Annual Budget of the Province and the LGUs, respectively;
13. Provide coordinative linkages with other agencies and institutions in the planning, monitoring, and evaluation of plans for children;
14. Recommend local legislation promoting child survival, protection, participation, and development, especially on the quality of television shows and media prints and coverage, which are detrimental to children, and with appropriate funding support;
15. Monitor and evaluate the implementation of the children's program and submit quarterly status reports to the Chairman, PCPC; *and*
16. Perform such other functions as provided for in the ECCD Law (R.A. 8980) and other child-related laws.

Secretariat support shall be provided by the Provincial Social Welfare and Development Office. The Secretariat shall be responsible for the documentation of proceedings of meetings and preparation of the reports and other necessary documents as needed by the Council and shall provide administrative and technical support services to PCPC.

Dear Ma'am:

Reference is made to your indorsement dated May 15, 2023, which was received by this office on May 24, 2023, requesting for legal opinion and recommendation on Executive Order No. \_\_\_\_\_ entitled: **"AMENDING THE MEMBERSHIP OF THE PROVINCIAL COUNCIL FOR THE PROTECTION OF CHILDREN IN THE PROVINCE OF PANGASINAN"**.

With all due respect, this office observes minor typographical errors and possible omission of words/ phrases in the previous submission dated May 15, 2023. Thereafter, we received a copy of the new version on June 19, 2023, and it appears that our previous observations and recommendations were duly considered.

The subject EO is in conformity with the declaration of policy set forth in Section 1 of the Republic Act No. 4881 entitled "An Act Creating a Council for the Protection of Children in Every City and Municipality of the Philippines and for Other Purposes". Thus:

Section 1. It is the declared policy of the State not only to assure that every family should be helped into bringing up their children to make them useful men and women but also to see that the proper direction, supervision and guardianship in the training, education, and other interests of its minor citizens by undertaken by it.

The Provincial Council for the Protection of Children serves as the umbrella organization for all children's concerns. It is a council fully harnessed to be an efficient and effective advocate of child's rights that implements all children's programs at the local levels. One of its roles is the conduct of advocacy activities on the promotion and protection of the rights and welfare of children including the development of information, education and advocacy materials.

Moreover, it can be justified under the following provisions of Republic Act No. 7160 or the Local Government Code of 1991, to quote:

*Sec. 465. The Chief Executive: Powers, Duties, Functions, and Compensation xxx.*

*(b) For efficient, effective and economical governance the purpose of which is the general welfare of the province and its inhabitants pursuant to Section 16 of this Code, the provincial governor shall:*

(1) *Exercise general supervision and control over all programs, projects, services, and activities of the provincial government, and in this connection, shall:*

(ii) *Direct the formulation of the provincial development plan, with the assistance of the provincial development council, and upon approval thereof by the Sangguniang Panlalawigan, implement the same;*


(2) *Enforce all laws and ordinances relative to the governance of the province and the exercise of the appropriate corporate powers provided for under Section 22 of this Code, implement all approved policies, programs, projects, services and activities of the province and, in addition to the foregoing, shall:*

(iii) *Issue such executive orders for the faithful and appropriate enforcement and execution of laws and ordinances;”*

Premises considered, undersigned finds no legal impediments in the provisions of the subject Executive Order, and we respectfully recommend the execution/ signing of the same.
