

EXECUTIVE ORDER NO. 0052-2023

**AN ORDER RE-ORGANIZING THE PROVINCIAL COMMUNITY-BASED
MONITORING SYSTEM (CBMS) COORDINATING BOARD**

WHEREAS, Republic Act (RA) No. 11315 otherwise known as Community-Based Monitoring System (CBMS) Act was enacted on 17 April 2019, institutionalizing the conduct of the CBMS in every City and Municipality in the country;

WHEREAS, the CBMS is an organized technology-based system of collecting, processing and validating necessary disaggregated data that may be used for planning, program implementation and impact monitoring at the local level while empowering communities to participate in the process;

WHEREAS, Section 4 of the Act states each City and Municipality is the primary data collecting authority within its locality;

WHEREAS, Section 6 of the Act states that the Philippine Statistics Authority (PSA) shall serve as the lead agency in the implementation of the CBMS, and shall monitor the data collection by Cities and Municipalities to ensure adherence to official concepts, definitions and standards of poverty statistics;

WHEREAS, section 14 of the Act provides for the creation of the CBMS Council composed of the PSA, Department of Interior and Local Government (DILG) and Department of Information and Communications Technology (DICT), to be headed by the PSA, for purposes of achieving secure and efficient data sharing arrangements between, and among concerned Cities and Municipalities and National Government Agencies to be used for their particular social protection and welfare programs and projects;

WHEREAS, the CBMS Council approves Resolution No. 06, Series of 2021 on the establishment of the Provincial and City/Municipal Coordinating Board that shall be responsible in overseeing the CBMS operations in their respective locality, ensuring logistic and other requirements are in place prior and during the CBMS operations, resolving issues and concerns encountered in the conduct of CBMS in their jurisdiction;

NOW THEREFORE, I, RAMON V. GUICO III, Governor of the Province of Pangasinan, through the powers vested in me by law, do hereby order the following:

SECTION 1. COMPOSITION OF THE PROVINCIAL CBMS COORDINATING BOARD.

SECTION 2. FUNCTIONS OF THE PROVINCIAL CBMS COORDINATING BOARD. The Provincial CBMS Coordinating Board (PCCB) shall perform the following functions:

1. Oversee the implementation of the CBMS operations in the province. Report status to the concerned Regional Statistical Committee (RSC).
2. Resolve issue and concerns encountered in the conduct of CBMS. For issues that cannot be resolved at the provincial level, escalate to the concerned PSA Regional Statistical Services Offices and RSCs.
3. Issue communications, directives, instructions, and/or circulars to cooperate, mobilize and provide support/assistance to the CBMS operations in area but not limited to the conduct/provision of the following:
 - a. Active participation in coordination meetings and activities;
 - b. Publicity and information campaign for the conduct of CBMS;
 - c. Venue for the training conduct, headquarters for the enumeration personnel, and machine processing;
 - d. Transportation facilities for the enumeration personnel, and transport of CBMS forms, supplies, and materials;
 - e. Communication and wireless internet connection facility;
 - f. Storage are for tablets, forms, and other materials;
 - g. Health and legal services to CBMS personnel; and
 - h. Facilitation of enumeration in government-owned and private institutions, and other hard-to-reach areas.
4. Take up other matters as necessary for the successful conduct of the CBMS.

SECTION 3. REPEALING CLAUSE. All Executive Orders or issuances inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly

SECTION 4. EFFECTIVITY. This Executive Order shall take effect immediately upon signing hereof.

Reference is made to the attached draft Executive Order No. ____ entitled: An Order Re-Organizing The Provincial Community-Based Monitoring System (CBMS) Coordinating Board.

The Provincial Community-Based Monitoring System (CBMS) Coordinating Board is a body responsible for the effective implementation and coordination of the CBMS at the provincial level. The CBMS is a comprehensive information system that aims to gather data and monitor the socio-economic conditions of communities, providing valuable insights for evidence-based planning and development initiatives. To enhance the efficiency and effectiveness of the CBMS, an order has been issued to reorganize the Provincial CBMS Coordinating Board.

The primary aim of reorganizing the Provincial CBMS Coordinating Board is to strengthen its capacity and streamline its functions. The reorganization seeks to improve coordination, enhance data quality and reliability, and promote the utilization of CBMS data for informed decision-making and policy formulation at the provincial level. By aligning the board's structure and functions, the aim is to maximize the benefits derived from the CBMS.

In accord with Republic Act No. 11315, An Act Establishing A Community-Based Monitoring System and Appropriating Funds Therefore, was signed into law on 17 April 2019 by President Rodrigo Roa Duterte. The law enables the Philippines' adoption of a community-based monitoring system which generates updated disaggregated data necessary in targeting beneficiaries, conducting more comprehensive poverty analysis and needs prioritization, designing appropriate policies and interventions and monitoring impact over time.

Premises considered, and after a scrutiny of the provisions of the said executive order, **this office finds no legal impediments in the provisions thereof.**
