Executive Order No. 0149-A-2022

"RECONSTITUTING THE PROVINCIAL SCHOOL BOARD OF THE PROVINCE OF PANGASINAN, IDENTIFYING ITS MEMBERS, THEIR DUTIES AND FUNCTIONS AND OTHER PURPOSES"

WHEREAS, Article 184 of the Implementing Rules and Regulations of the Local Government

Code of 1991 (RA 7160) mandates the creation of the Local School Board (LScB);

WHEREAS, education stand as one of the core priorities of the Provincial Government, recognizing its importance as a great equalizer towards a better quality of life and as a building block of developing a culture of excellence:

WHEREAS, the recent local election requires reconstitution of the LScB due to the end of term of office of former LScB members; and

NOW, THEREFORE, **I, RAMON V. GUICO III,** Provincial Governor of Pangasinan, by virtue of the powers vested in me by the law, do hereby order the reconstitution of the of the Province of Pangasinan, with the following stipulations:

Section 1. Composition

The LScB of the Province of Pangasinan shall be composed of the following;

Section 2. Duties and Functions of the LScB

The LScB shall perform the following functions:

- a) Determine, in accordance with the criteria set by the Department of Education, the annual supplementary budgeting needs for the operation and maintenance of the public schools within the province and the supplementary local cost of meeting such needs, which shall be reflected in the form of an annual school. board budget corresponding to its share of the proceeds of the special levy on real property constituting the Special Education Fund and such other sources of revenue as the Local Government Code of 1991 (RA7160) and other laws or ordinances may provide;
- Authorize the Provincial Treasurer to disburse funds from the Special Education Fund (SEF) pursuant to the budget prepared and in accordance with the existing rules and regulations;
- Serve as an advisory Committee to the Sangguniang Panlalawigan on educational matters, such as, but not limited to the necessity for the uses of local appropriations for educational purposes; and
- d) Recommend changes in the name of public schools within the territorial jurisdiction of the local government unit for enactment of the Sangguniang Panlalawigan.

The Department of Education, Culture and Sports shall consult the LScB on the appointment of division superintendents, district supervisors, school principals, and other school

officials.

Section 3. Meetings and Quorum

- a) The LScB shall meet at least once a month or as often as maybe necessary.
- b) Any of the co-chairperson may call a meeting. A majority of all its members shall constitute a quorum. However, when both co-chairpersons are present in a meeting, the local chief executive concerned, as a matter of protocol, shall be given preference to preside over the meeting. The division superintendent, shall prepare the budget of the LScB. Such budget shall be supported by programs, projects, and activities of the school board for the ensuing fiscal year. The affirmative vote of the majority of all members shall be necessary to approve the budget.

Section 4. Budget

The annual school board budget shall give priority to the following:

- a) Construction, repair, and maintenance of school buildings and other facilities of public elementary and secondary schools;
- b) Establishment and maintenance of extension classes where necessary; and
- c) Sports activities at the division, district, municipal, and barangay levels.

Section 5. Compensation and Remuneration

The co-chairperson and members of the provincial school board shall perform their duties as such without compensation or remuneration. Members thereof who are not government officials or employees shall be entitled to necessary travelling expenses and allowances chargeable against the funds of LScB, subject to existing accounting and auditing rules and regulations.

Section 6. Secretariat

The Board shall be assisted by a Secretariat, to be headed by Ms. Dolores Vinuya, OIC-Provincial Budget Office, who shall provide technical and administrative support to the board.

Section 7. Repealing Clause

All Executive Orders or issuances inconsistent with the provisions of this Executive Order are hereby repealed, superseded or modified accordingly.

Section 8. Effectivity

This Executive Order shall take effect immediately.
