WHEREAS, Memorandum Circular 2004-78 of the Department of the Interior and Local Government mandates the reorganization of the local Project Monitoring Committee in the Local Government Units;

WHEREAS, the conduct of regular monitoring and evaluation of projects is to be implemented by the Local Development Council as per directive under Memorandum Order No. 175 dated May 23, 1988 originally establishing Provincial Project Monitoring Committee (PPMC) as the monitoring arm of the province;

WHEREAS, monitoring and evaluation of development projects and programs is an important responsibility assigned to the Local Development Council to provide up-to-date information of the over-all status of project implementation and identify problems/issues which impede project implementation so that remedial measures could be instituted;

WHEREAS, Executive Order No. 0179-2022 reconstituted the PPMC of Pangasinan on October 10, 2022 due to the change of administration in the Provincial Government and the retirement, and end of term of office of some of its former members;

WHEREAS, there is a need to reconstitute the PPMC due to the change, promotion, and retirement of some of its members;

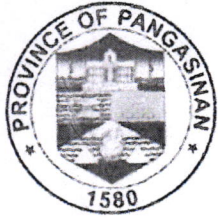

WHEREAS, Memorandum Circular 2004-78 of the Department of the Interior and Local Government mandates the reorganization of the local Project Monitoring Committee in the Local Government Units;

WHEREAS, the conduct of regular monitoring and evaluation of projects is to be implemented by the Local Development Council as per directive under Memorandum Order No. 175 dated May 23, 1988 originally establishing Provincial Project Monitoring Committee (PPMC) as the monitoring arm of the province;

WHEREAS, monitoring and evaluation of development projects and programs is an important responsibility assigned to the Local Development Council to provide up-to-date information of the over-all status of project implementation and identify problems/issues which impede project implementation so that remedial measures could be instituted;

WHEREAS, based on the above premises, the Provincial Government would like to ensure the seamless transition to the new administration including the continuity of the functions of the PPMC;
