PROVINCIAL RESOLUTION NO. 1-2018

APPROVING THE LOCAL ROAD NETWORK DEVELOPMENT PLAN (LRNDP) FOR CALENDAR YEARS 2018-2022 OF THE PROVINCE OF PANGASINAN

WHEREAS, presented for consideration by the Sangguniang Panlalawigan is the Local Road Network Development Plan (LRNDP) for Calendar Years 2018-2022 of the Province of Pangasinan as endorsed by the Provincial Development Council through PDC Resolution No. 4, Series of 2017;

WHEREAS, LRNDP is an integrated five-year development plan for the sustainable development of provincial road networks and contains core road projects which were selected based on prioritization criteria and consistent with and in support of the goals and objectives of the Provincial Government of Pangasinan;

WHEREAS, local government units are required to prepare their Local Road Network Development Plan in order to participate in the Conditional Matching Grant to Provinces (CMGP) for Road Repair, Rehabilitation and Improvement of the Department of the Interior and Local Government;

WHEREAS, the CMGP is a program of the national government through the Department of the Interior and Local Government and Department of Budget and Management in order to fund local roads;

WHEREAS, it is a performance-based downloading of fund program which will be sent directly to the provincial government upon completion of various requirements for the rehabilitation, improvement and upgrading of provincial roads;
