PROVINCIAL RESOLUTION NO. 1-2019

ENDORING TO THE DEPARTMENT OF HEALTH THE APPLICATION FOR A LICENSE TO OPERATE A 50-BED CAPACITY OF THE MANGATAREM DISTRICT HOSPITAL, PROVINCE OF PANGASINAN

WHEREAS, the Mangatarem District Hospital, one of the 14 hospitals operated by the Provincial Government of Pangasinan, caters to patients coming from the different municipalities of the 2nd District of Pangasinan;

WHEREAS, the Mangatarem District Hospital intends to increase its bed capacity from 25 to 50 or an increase of 100% in authorized bed capacity;

WHEREAS, at present, there is a significant increase in the number of patients being serviced by the hospital and occupancy rate, thereby exceeding its 25-authorized bed capacity;

WHEREAS, the hospital has recorded an average of sixty to seventy-five (60-75) admissions based on its daily census and statistics which qualifies it to be upgraded from 25 to 50;

WHEREAS, in line with the main thrusts of the present administration to have a mass-based health care program to accommodate all people especially the less fortunate sector of society, there is a need to support the plan of the Mangatarem District Hospital to provide a more sufficient and higher level of medical and health services to its patients by increasing its bed capacity from 25 to 50;
