PROVINCIAL RESOLUTION NO. 1-2022

AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO TERMS OF PARTNERSHIP WITH THE DEPARTMENT OF HEALTH – CENTER FOR HEALTH DEVELOPMENT-I FOR THE IMPLEMENTATION OF THE LOCAL INVESTMENT PLAN FOR HEALTH THROUGH THE 2022 ANNUAL OPERATIONAL PLAN OF THE PROVINCE OF PANGASINAN

WHEREAS, the Fourmula One Plus for Health, the flagship program of the Department of Health with its tagline “Boosting Universal Health Care, is the strategic framework for health sector reforms in the country;

WHEREAS, the implementation of Fourmula One Plus for Health is directed towards achieving the following health system end goals identified in the Philippine Development Plan, Sustainable Development Goals, and the Ambisyon Natin 2040, specifically for better health outcomes, more equitable health care financing, and more responsive health system;

WHEREAS, the Local Investment Plan for Health (LIPH) shall serve as a key instrument to forge the partnership between the Department of Health and the Province of Pangasinan to carry out the objectives of the Fourmula One Plus for Health in the implementation and consolidation of support for health reforms in the Province;

WHEREAS, through the LIPH, the Province of Pangasinan shall receive financial and non-financial allocation support from DOH for the implementation of its approved Annual Operational Plan for 2022;

WHEREAS, the LIPH guarantees the implementation of programs/projects/activities in the Province of Pangasinan, together with its component LGUs, toward achieving a more responsive health system and equitable health care financing;

WHEREFORE, in view of the foregoing, on motion of SP Member Jeremy Agerico B. Rosario, duly seconded, it was –


