THIS IS TO CERTIFY that at the special session duly constituted of the Sangguniang Panlalawigan, Province of Pangasinan, held on January 7, 1991, at Lingayen, Pangasinan, the following Provincial Ordinance was approved:

PROVINCIAL ORDINANCE NO. 10-1991

ORDINANCE CREATING BARANGAY LONGOS PROPER, AMANGONAN PARAC-PARAC FABRICA, CABARUAN, ALACAN, TIBLONG AND INMALOG AND INMALOG NORTE AS NEW AND INDEPENDENT BARANGAYS OF THE MUNICIPALITY OF SAN FABIAN, PROVINCE OF PANGASINAN

WHEREAS, this body is in receipt of a Resolution of the Sangguniang Bayan of San Fabian, Pangasinan requesting the Sangguniang Panlalawigan of Pangasinan (this body) to favorably act on the petitions of residents of six sitios in San Fabian, Pangasinan to be created as new and independent barangays to be named as Barangay Longos Proper, Barangay Amangonan Parac-Parac Fabrica, Barangay Cabaruan, Barangay Alacan, Barangay Tiblong and Barangay Inmalog Norte pursuant to law;

WHEREAS, pursuant to law on the matter, all the essential requirements therein have been satisfactorily met;

WHEREAS, the residents and leaders therein are of the firm belief that the creation would hasten social, economic and political development in the area and would definitely foster faster delivery of the basic services;

NOW, THEREFORE, in view of the foregoing, on motion of Board Member Dionisio C. Antiniw, duly seconded by Board Members Jose P. Castillo and Editha G. Demetria, it was -

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to create as it is hereby created the following new and independent barangays in San Fabian, Pangasinan in accordance with the provisions hereto;

Section 1. This Ordinance shall be known as the Ordinance creating Barangay Longos Proper (from mother Barangay Longos), Barangay Amangonan Parac-Parac Fabrica (from mother Barangay Longos), Barangay Cabaruan (from mother Barangay Angio), Barangay Alacan (from mother Barangay Mabilao), Barangay Tiblong (from mother Barangay Rabon) and Barangay Inmalog Norte (from mother Barangay Inmalog);

Section 2. Six (6) new and independent barangays are hereby created from five (5) mother barangays in the Municipality of San Fabian, Province of Pangasinan, to wit:

Section 3. The six (6) new and independent barangays shall have the following boundaries as described below -

Barangay Longos Proper

- N - Road going to Bonuan-Binloc
- E - National Highway (MacArthur)
- S - Bantayan (Mangaldan)
- W - River Boundary with Dagupan City

Barangay Amangonan Parac-Parac Fabrica

- N - Cayanga River
- E - National Highway (MacArthur)
- S - Road going to Bonuan-Binloc
- W - River boundary with Dagupan City

Barangay Cabaruan

- N - Boundary with Barangay Anonang (monument)
- E - Boundary with San Jacinto, Pangasinan (monument)
- S - Boundary with Brgy. Lekep-Bitao, San Fabian, Pangasinan
- W - Culvert (Canal)

Barangay Alacan

- N - River and Philippine Cotton Corporation Complex
- E - Brgy. Lipit and hills
- S - Railroad tracks (PNR)
- W - Lingayen Gulf

Barangay Tiblong

- N - Road Post Km. 101
- E - Sitio Lupa-Lupa
- S - National Highway
- W - Lingayen Gulf


Barangay Imalang Norte

- N - Cemented Monument
- E - Bolaoen acacia tree near it
- S - Creek
- W - Road


Section 4. The expenses for the plebiscite to be conducted in the five mother barangays aforementioned including the six (6) sitios also mentioned shall be shouldered by the Municipality of San Fabian.

Section 5. The COMELEC shall conduct the plebiscite, simultaneously in one day in the affected areas of the Municipality of San Fabian, Province of Pangasinan in accordance with law.

Section 6. This Ordinance shall take effect immediately.
