DECLARING MUNICIPAL ORDINANCE NO. 5, S-2021 OF THE SANGGUNIANG BAYAN OF MAPANDAN. ENTITLED "AN ORDINANCE CREATING SIXTEEN POSITIONS UNDER THE FOLLOWING EXECUTIVE LEGISLATIVE OFFICES: 1. MAYOR'S OFFICE, 2. LDRRM OFFICE, 3. HR OFFICE, 4. BUDGET OFFICE, 5. ACCOUNTING OFFICE, 6. MUNICIPAL HEALTH OFFICE, 7. MSWD OFFICE, 8. ENGINEERING OFFICE AND SANGGUNIANG BAYAN OFFICE IN **MUNICIPALITY** OF MAPANDAN, **PROVINCE** PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT
