DECLARING MUNICIPAL ORDINANCE NO. 31, S-2021 OF THE SANGGUNIANG BAYAN OF AGUILAR, PANGASINAN, ENTITLED "AN ORDINANCE CREATING VARIOUS PLANTILLA POSITIONS IN THE EXECUTIVE AND LEGISLATIVE DEPARTMENTS OF THE MUNICIPAL GOVERNMENT OF AGUILAR, PANGASINAN, DETERMINING ITS DUTIES AND RESPONSIBILITIES, AND PROVIDING FUNDS THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT
