DECLARING MUNICIPAL ORDINANCE NO. 8, S-2021 OF THE SANGGUNIANG BAYAN OF BAUTISTA, PANGASINAN, ENTITLED “AN ORDINANCE CREATING POSITION FOR LABORATORY TECHNICIAN II (SG-8) IN THE LOCAL GOVERNMENT UNIT OF BAUTISTA, PANGASINAN AND PROVIDING FUND THEREOF EFFECTIVE JANUARY 1, 2022” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT
