RESOLUTION NO. 102-2022

DECLARING THE ANNUAL BUDGET FOR CY 2022 OF MANGATAREM, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P366,331,378.00, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Mangatarem, Pangasinan submitted its Annual Budget for Calendar Year 2022 involving total appropriations of P366,331,378.00, which was enacted on November 17 2021 through Appropriation Ordinance No. 03, Series of 2021;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. That the implementation of the Third Tranche Compensation Adjustment for municipal officials and employees shall be subject to the provisions of Executive Order No. 76 of the Office of the President dated March 15, 2019 and specific guidelines to be issued by the Department of Budget and Management;

2. That the grant of step increment to some municipal officials and employees shall be in accordance with DBM-CSC Joint Circular No. 1, S-2012 dated September 3, 2012 and CSC-DBM Joint Circular No. 01, S-2016 dated January 27, 2016. The salary grade allocation and appropriation for salaries of SG-19/1-Engineer III (Agriculture and Biosystems Engineer) newly created position thru Ordinance No. 03-2021 from the Office of the Municipal Agriculturist shall be in accordance with DA-DBM-CSC-DILG Joint Memorandum Circular No. 02 series of 2020 dated June 24, 2020;
3. That the purchase of Transportation Equipment Outlay shall be in accordance with the provisions of DILG Memorandum Circular No. 2021-04 dated January 18, 2021;
4. That the utilization of all appropriations for Capital Outlay, shall, as may be applicable, be subject to the authorization of the Sanggunian on the list of projects to be implemented as rules by the Supreme Court in the case of Hon. Gabriel Luis Quisumbing, et al vs. Hon. Gwendolyn F. Garcia, et al., G.R. No. 175527, December 8, 2008;
5. That all appropriation for Public Affairs Fund and those under the Special Purpose Appropriations be spent solely for public purposes and no amount shall be applied for religious or private purposes pursuant to Section 305 (b) and 335 of R.A. 7160, and shall be broken down into appropriate objects of expenditures, as may be applicable in accordance with the New Government Accounting system (NGAs);
6. That the appropriation for the payment of Terminal Leave Benefits (TLB) of retired LGU personnel shall be subject to the provisions of DBM Budget Circular No. 2016-2 dated March 29, 2016 re: Computation and Funding of Terminal Leave Benefits and Monetization of Leave Credits, which provides for the new constant factor stated under Item 3.1 thereof;
7. That the appropriation and disbursement of Election Reserve shall be in accordance with COMELEC Resolution No. 10695 promulgated on February 10, 2021;
8. That the items funded out of the Local Disaster Risk Reduction and Management Fund shall be in accordance with R.A. No. 10121 known as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR, and the DBM-NDRRM-DILG Joint Memorandum Circular No. 2013-1 dated March 25,

- 2013 re: Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund (LDRRMF) and that 30% shall be set aside as Quick Response Fund;
9. That the projects under the (20%) Annual Internal Revenue Allotment for development projects (20% Development Fund) shall be subject to the provisions of DBM - DOF - DILG Joint Memorandum Circular (JMC) No. 1 dated November 4, 2020, Revised Guidelines on the Appropriation and Utilization of Twenty Percent (20%) of the Annual Internal Revenue Allotment (IRA) for Development Projects);
 10. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2022 Annual Investment Program of the municipality formulated to pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated March 8, 2007;
 11. That all procurement to be undertaken shall strictly be subject to the pertinent provisions of R.A. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations; and
 12. That the appropriation for devolved functions and services for FY 2022 shall be in accordance with the provisions of Executive Order No. 138 dated June 1, 2021 and DBM-DILG Joint Memorandum Circular No. 2021-1 dated August 11, 2021 shall be consistent with Devolution Transition Plan of the municipality.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Nestor D. Reyes and Von Mark R. Mendoza and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety the Annual Budget for Calendar Year 2022 of Mangataram, Pangasinan;


