DECLARING MUNICIPAL ORDINANCE NO. 11, S-2021 OF THE SANGGUNIANG BAYAN OF BAUTISTA, PANGASINAN, ENTITLED “AN ORDINANCE TRANSFERRING THE POSITION OF ADMINISTRATIVE AIDE VI (PLANTILLA ITEM NO. X-7) FROM THE OFFICE OF THE MUNICIPAL ACCOUNTANT TO THE OFFICE OF THE PESO MANAGER EFFECTIVE JANUARY 1, 2022” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT
