**PROVINCIAL RESOLUTION NO. 1023-2021**

**INVITING THE PROVINCIAL HEALTH OFFICER, PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICER AND THE PROVINCIAL DIRECTOR OF THE PHILIPPINE NATIONAL POLICE TO A QUESTION HOUR OF THE SANGGUNIANG PANLALAWIGAN DURING ITS DECEMBER 6, 2021 REGULAR (PHYSICAL) SESSION TO UPDATE THE BODY ON THE STATUS OF COVID-19 CASES AND THE PRESENT DIRECTION OF THE PROVINCE TO FURTHER COMBAT THE DISEASE**

**WHEREAS**, the Province of Pangasinan is now experiencing a continuous decline on the average number of COVID-19 cases for the past weeks;

**WHEREAS**, the Sangguniang Panlalawigan has observed that social gatherings are already up again and it is as if that everything is back to normal so the people should be constantly reminded to observe the minimum public health and safety protocols as the threat of COVID-19 is just around the corner;

**WHEREAS**, the Sangguniang Panlalawigan also expresses concern that a new coronavirus variant called Omicron is currently spreading around the world affecting several countries already;

**WHEREAS**, this prompted the Sangguniang Panlalawigan to schedule again a Question Hour and invite the Members of the Provincial Inter-Agency Task Force (IATF) to shed light on the current situation of COVID-19 cases in the Province and recommend to the Body the health and safety protocols that need to be continued to be implemented in some areas like the use of face shield, if necessary;
