APPROVING RESOLUTION NO. 634. S-2020 OF THE SANGGUNIANG BAYAN OF BAYAMBANG, PANGASINAN, ENTITLED **"APPROVING** THE ANNUAL INVESTMENT **PROGRAM (AIP) OF THE MUNICIPALITY OF BAYAMBANG FOR CALENDAR YEAR 2021"**

WHEREAS, the Sangguniang Bayan of Bayambang, Pangasinan submitted its Resolution No. 634, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Municipal Development Council of Bayambang, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for CY 2020. This was endorsed by the Council to the Sangguniang Bayan thru MDC Resolution No. 09-002, Series of 2020 dated September 25, 2020 and was favorably acted upon by the Sangguniang Bayan through SB Resolution No. 634, S-2020 dated October 5, 2020;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of Bayambang, Pangasinan was prepared using the prescribed AIP Summary Form, and covers: a) all the regular budgetary requirements for the operation of the different offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority development programs/projects of the LGU including t hose to be funded by the 20%

> development fund, c) Disaster Risk Reduction (DRR) Programs/Projects/Activities, and d) activities in pursuance of the objectives of GAD of the LGU as indicated in the DILGendorsed GAD Plan and Budget. Also attached to the AIP, among others, are the following: a) Local Climate Change Investment Plan, b) Peace and Order Plan, c) Culture Development Plan, d) Indicative Annual Procurement Plan, e) list of programs/projects/activities (PPAs) for the Local Council for the Protection of Children, f) list of PPAs for Senior Citizens and Persons with Disability, g) list of PPAs for HIV, h) Municipal Anti-Drug Abuse Council (MADAC) Plan, and i) Nutrition Action Plan of the LGU;

> WHEREAS, the proposed AIP of Bayambang for CY 2021 has a total investment requirement of P1,575,482,915.09. Of this, the sum of P625,517,399.09 will be financed by the LGU as embodied in their 2021 proposed Annual Budget passed and approved by the Sangguniang Bayan through Appropriation Ordinance No. 3, S-2020 (for the General Fund/ P579,275,498.79) and Appropriation Ordinance No. 4, S-2020 (for the Special Economic Enterprise / P46,241,900.30) dated October 5, 2020. The remaining amount, estimated at P949,965,516.00, will be derived from external sources;

WHEREAS, this AIP is in accordance with Section 287 of RA 7160. Twenty percent (20%) of the LGUs IRA (P301,609,742.00), amounting to P60,321,948.40 is allocated for development projects;

WHEREAS, the development projects proposed to be funded by the 20% development fund were based on the DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects";

WHEREAS, the programs, projects and activities included in the Municipal Disaster Risk Reduction and Management Investment Plan, amounting to P23,730,487.10, are in accordance to Section 21 of RA 10121 and Memorandum Circular No. 2013-1 of the NDRRMC, DBM and DILG dated March 25, 2013 (Joint Allocation and Utilization of Local Disaster Risk Reduction and Management Fund);

WHEREAS, the LGU's LDRRM Plan was reviewed and evaluated by the Office of the Civil Defense – Regional Office 1;

WHEREAS, the LGU of Bayambang had also identified programs, projects and activities responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;

WHEREAS, the Gender and Development Plan and Budget for CY 2020 of the LGU has been reviewed and approved by the Department of Interior and Local Government (DILG) Provincial Office, and found to be compliant in form and in contents with the provisions of the DBM, PCW, DILG & NEDA Joint Memorandum Circular No. 2016-01 entitled "Amendments to JMC 2013-01 or the Guidelines on the Localization of Magna Carta of Women";

WHEREAS, the AIP of the subject municipality also included projects for funding from external sources, such as NGAs;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order provided that the deficiency in the appropriation of 5% LDRRM Fund amounting to P1,210,140.00 shall be appropriated in the first Supplemental Budget of the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Vici M. Ventanilla and Angel M. Baniqued, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia and Jerome Vic O. Espino, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 634, S-2020 of the Sangguniang Bayan of **Bayambang**, Pangasinan, entitled "Approving the Annual Investment Program (AIP) of The Municipality of Bayambang for Calendar Year 2021";

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Bayambang, Pangasinan, for its information and guidance.
