PROVINCIAL RESOLUTION NO. 1025-2021

APPROVING THE DEVOLUTION TRANSITION PLAN (DTP) OF THE PROVINCE OF PANGASINAN FOR CALENDAR YEARS 2022-2024

WHEREAS, presented for consideration is the Devolution Transition Plan (DTP) of the Province of Pangasinan for Calendar Years 2022-2024 as endorsed by the Provincial Development Council through PDC Resolution No. 02, Series of 2021;

WHEREAS, the Devolution Transition Plan contains newly and partially devolved functions/services by the National Government Agencies (NGAs) in accordance with Section 17 of RA 7160, otherwise known as the Local Government Code of 1991 and other existing laws;

WHEREAS, funding for the implementation of these fully devolved responsibilities will come primarily from the share of the province in the proceeds of national taxes;

WHEREAS, with the substantial increase in financial resources, the Province would be more capable of providing the basic services and facilities needed by the people;

WHEREAS, after a careful study and evaluation on the said Devolution Transition Plan, the Sangguniang Panlalawigan has found the same to be advantageous and beneficial to the Province and in keeping with pertinent laws;

NOW, THEREFORE, on motion of SP Member Angel M. Baniqued, Jr., duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan of Pangasinan to approve, as it is hereby approved, the Devolution Transition Plan (DTP) of the Province of Pangasinan for Calendar Years 2022-2024;






