**PROVINCIAL RESOLUTION NO. 1026-2020**

**AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH STA. ANA HEALTHCARE PLUS CORPORATION (SAHPC) FOR THE PROVISION, INSTALLATION, COMMISSIONING, OPERATION AND MAINTENANCE OF TEN (10) DIALYSIS MACHINES AND OTHER ANCILLARY EQUIPMENT TO BE LOCATED AT THE WESTERN PANGASINAN DISTRICT HOSPITAL**

**WHEREAS**, the Province of Pangasinan has been continuously embarking on new projects and programs to upgrade and rehabilitate its fourteen provincial government hospitals;

**WHEREAS**, the Province of Pangasinan intends to put up a hemodialysis facility at the Western Pangasinan District Hospital to help patients needing dialysis treatments;

**WHEREAS**, the Sta. Ana Healthcare Plus Corporation, a capable and reputable company, has offered its services to set-up a hemodialysis facility at the Western Pangasinan District Hospital;

**WHEREAS**, the Province shall, in turn, exclusively purchase from Sta. Ana Healthcare Plus Corporation consumables necessary for the use and operation of the machines during the six-year agreement period;

**WHEREAS**, the equipment could further enhance better and more accessible ways of public health and medical services to the people of Pangasinan, especially the underprivileged;

**WHEREAS**, in the above purpose, a MOA shall be signed and entered into between the Province of Pangasinan, represented by Provincial Governor Amado I. Espino III, and Sta. Ana Healthcare Plus Corporation, represented by Ryan Pel B. Pangilinan, Chief Executive Officer;
