PROVINCIAL RESOLUTION NO. 1027-2020

APPROVING THE ANNUAL INVESTMENT PROGRAM (AIP) OF THE PROVINCE OF PANGASINAN FOR CALENDAR YEAR 2021

WHEREAS, presented for consideration by the Sangguniang Panlalawigan is the Annual Investment Program (AIP) of the Province of Pangasinan for CY 2021 as endorsed by the Provincial Development Council thru PDC Resolution No. 01, S-2020;

WHEREAS, the Annual Investment Program of the Province of Pangasinan embodies the priority programs, projects and activities that address the basic sectors of development to be implemented in CY 2021;

WHEREAS, a total amount of P4,827,769,464.00 is required to finance the full implementation of the various programs and projects in the said AIP;

WHEREAS, said AIP is anchored on “Abig Pangasinan”, a recovery plan of the province to address the effects of the COVID 19 pandemic focusing on the following thrusts: Improved Health System, Increased Agricultural Productivity, Livelihood Assistance, Manpower Development and Employment, Social Welfare Services, Tourism Development and Promotion Activities, Environment/Disaster Risk Reduction Management, and Infrastructure Support Development;

WHEREAS, the AIP of the province for CY 2021 also includes, as its accompanying document, the programs, projects and activities of the national government agencies to be implemented in the Province of Pangasinan with the total investment requirement of P25,815,611,303.00, as well as the proposed programs/projects for investment priority areas;

WHEREAS, the AIP of the Province for CY 2021 will serve as a vehicle for the delivery of the basic socio-economic services and facilities for the progress and development of Pangasinan;


WHEREAS, after a careful study of the said AIP, this august Body finds it to be in order;

WHEREFORE, on motion of SP Member Angel M. Baniqued, Jr., duly seconded, it was –


