PROVINCIAL RESOLUTION NO. 1030-2020

INVITING ANEW THE PNP PROVINCIAL DIRECTOR, POLICE COLONEL REDRICO A. MARANAN, AND PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICER, COL. RHODYN LUCHINVAR O. ORO, TO A QUESTION HOUR ON ITS NOVEMBER 16, 2020 REGULAR (WEB-BASED/ONLINE) SESSION TO UPDATE THE BODY ON THE IMPLEMENTATION OF HEALTH AND SAFETY PROTOCOLS TO CONTAIN THE SPREAD OF COVID-19 IN THE PROVINCE

WHEREAS, the Province of Pangasinan still remains under the Modified General Community Quarantine status, however, the Sangguniang Panlalawigan has already observed some changes to be taking place around the corners of the Province amidst the pandemic;

WHEREAS, among other safety protocols which have been relaxed are the implementation of checkpoints or opening of border control points, and the 8 p.m. – 5 a.m. curfew ordinance of the Province;

WHEREAS, although the Province is now experiencing a steady minimal increase in the number of confirmed COVID cases, the provincial government together with the concerned authorities should not be complacent but still continue to be vigilant in the implementation of health and safety protocols to combat COVID-19;

WHEREAS, it is the request of the Sangguniang Panlalawigan to be updated on the current situation of COVID-19 in the aspect of prevention in the Province of Pangasinan;

WHEREAS, the Sangguniang Panlalawigan, in collaboration with the Provincial Inter-Agency Task Force and Philippine National Police, will pursue to look for ways and means to enact and pass legislative measures to combat COVID-19;



WHEREFORE, on motion of SP Member Jeremy Agerico B. Rosario, duly seconded, it was –


