DECLARING ORDINANCE NO. 2021-026 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED “AN ORDINANCE INSTITUTIONALIZING SPORTS DEVELOPMENT IN THE CITY OF ALAMINOS, PAMNGASINAN AND CREATING THE CITY SPORTS DEVELOPMENT OFFICE AND ITS PERSONNEL COMPLIMENT FOR THE PURPOSE” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT


