**DECLARING ORDINANCE NO. 2021-29 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED “AN ORDINANCE INSTITUTIONALIZING LIBRARY SERVICES IN THE CITY OF ALAMINOS, PANGASINAN CONVERTING THE CITY LIBRARY AS A SECTION UNDER THE LEGISLATIVE DEPARTMENT TO A SEPARATE DEPARTMENT OF THE LOCAL GOVERNMENT UNIT OF THE CITY OF ALAMINOS, PANGASINAN AND CREATING THE POSITION OF CITY GOVERNMENT DEPARTMENT HEAD I AS HEAD OF THE AFORECIDED DEPARTMENT” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT**


