PROVINCIAL RESOLUTION NO. 1032-2020

AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN A MEMORANDUM OF UNDERSTANDING WITH THE DEPARTMENT OF SCIENCE AND REGIONAL TECHNOLOGY OFFICE NO. 1 FOR IMPLEMENTATION OF THE "INNOVATION, SCIENCE AND **TECHNOLOGY FOR ACCELERATING** REGIONAL TECHNOLOGY-BASED DEVELOPMENT" (iSTART) PROGRAM IN THE PROVINCE OF PANGASINAN

WHEREAS, the Department of Science and Technology (DOST) is mandated to provide central direction, leadership, and coordination of scientific and technological efforts and ensure that the results therefrom are geared and utilized in areas of maximum economic and social benefits for the people;

WHEREAS, the "Innovation, Science and Technology for Accelerating Regional Technology—Based Development" (iSTART) Program of the Department of Science and Technology aims to support geographically balanced development by accelerating regional growth through science, technology, and innovation;

WHEREAS, the Provincial Government of Pangasinan and Department of Science and Technology shall jointly undertake the Program in order to develop technology-based development plans for the agri-based, manufacturing, and service sectors; attract new technology-based investments in accordance with validated plans; and engage researchers, scientists, and/or engineers (RSEs) who will support technology-based investments and projects in the Province;

WHEREAS, the areas of cooperation and commitment between the Province of Pangasinan and the Department of Science and Technology are stipulated in the Memorandum of Understanding;
