APPROVING RESOLUTION NO. 2021-57 OF THE SANGGUNIANG BAYAN OF BOLINAO, PANGASINAN, ENTITLED "RESOLUTION ADOPTING THE REVISED ANNUAL INVESTMENT PROGRAM CY 2021 OF THE MUNICIPALITY OF BOLINAO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Bolinao, Pangasinan submitted its SB Resolution No. 2021-57 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R.A. 7160;

WHEREAS, the Local Development Council of Bolinao, Pangasinan endorsed to the Sangguniang Bayan for approval the Revised Annual Investment Program CY 2021 on September 10, 2021 through MDC Resolution No. 6, Series of 2021;

WHEREAS, the 2021 AIP of the Municipality of Bolinao was revised to integrate the Revised Gender and Development (GAD) Plan and Budget and disaster risk reduction and management programs/projects;

WHEREAS, the disaster risk reduction programs and activities were identified and prioritized by the LDRRM Council and endorsed through MDRRMC Resolution No. 2, Series of 2021 and proposed to be funded by the municipality's unexpended balances of their LDRRMF CYs 2017, 2018, 2019 and 2020 Trust Fund in the amount of P2,806,065.14. This is in accordance with Item 6.5 of NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 of the Department of Interior and Local Government;
