## **RESOLUTION NO. 1037-2021**

DECLARING MUNICIPAL ORDINANCE NO. 17-2021 OF THE SANGGUNIANG BAYAN OF MANAOAG, PANGASINAN, ENTITLED "AN ORDINANCE RECLASSIFYING THE 5000 SQ. M. AND 5461 SQ. M. LOT OWNED BY RAMON B. LEONOR, JR., FROM AGRICULTURAL AND RESIDENTIAL, RESPECTIVELY, INTO COMMERCIAL LOT PURPOSES LOCATED AT BARANGAY LELEMAAN, MANAOAG, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Manaoag, Pangasinan submitted its Ordinance No.17-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Provincial Planning and Development Coordinator, Provincial Agrarian Reform Program Officer II and Department of Human Settlements and Urban Development Regional Director have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 20 and 447(a) (2) (viii) of R.A. No. 7160;

**WHEREAS**, the Municipality of Manaoag has an existing Zoning Ordinance implementing its Comprehensive Land Use Plan CY 1996-2005. Said CLUP and Zoning Ordinance however, needs updating;

**RESOLVED,** by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 17-2021 of the Sangguniang Bayan of Manaoag, Pangasinan, entitled "An Ordinance reclassifying the 5000 sq. m. and 5461 sq. m. lot owned by Ramon B. Leonor, Jr., from agricultural and residential, respectively, into commercial lot purposes located at Barangay Lelemaan, Manaoag, Pangasinan" as within the conferred powers of the Sangguniang Bayan to enact;
