APPROVING RESOLUTION NO. 2018-116 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED "APPROVING AND ADOPTING THE ANNUAL INVESTMENT PROGRAM (AIP) CY 2019 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Resolution No. 2018-116 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Municipal Development Council of Mangaldan, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for CY 2019. This was endorsed by the Council to the Sangguniang Bayan thru MDC Resolution No. 12, S-2018 dated July 31, 2018 and was favorably acted upon by the Sangguniang Bayan on November 5, 2018 thru SB Resolution No. 2018-116;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint

Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of Mangaldan, Pangasinan was prepared using the prescribed AIP Summary Form, and covers: a) all the regular budgetary requirements for the operation of the different offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority development programs/projects of the LGU including those to be funded by the 20% development fund, c) Disaster Risk Reduction (DRR) Programs/Projects/Activities and d) Activities in pursuance of the objectives of GAD of the LGU;

WHEREAS, also attached to the AIP, among others, are the following: a) Local Climate Change Action Plan b) Peace and Order Plan, c) List of Programs/Projects/Activities (PPAs) for the Local Council for the Protection of Children, d) List of PPAs for Senior Citizens and Persons with Disability and e) PPAs to be funded by the external sources;

WHEREAS, the AIP of Mangaldan for CY 2019 has a total investment requirement of P2,367,454,458.00. Of this, P312,454,458.00 will be financed by the LGU as embodied in their 2019 Annual Budget passed and approved by the Sangguniang Bayan through Appropriation Ordinance No. 2018-119 dated November 5, 2018. The remaining amount of P2,055,000,000.00 will be funded by the different National Government Agencies and LGU's Loan from the Land Bank of the Philippines;

WHEREAS, said AIP is in accordance with Section 287 of RA 7160. Twenty percent (20%) of the LGUs IRA (P215,102,458.00) amounting to P43,020,491.60 is allocated for development projects;

WHEREAS, the development projects proposed to be funded by the 20% development fund were based on the DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects";

WHEREAS, the projects and activities included in the 5% Local Disaster Risk Reduction and Management Fund amounting to P13,987,722.90 are in accordance to Section 21 of RA 10121 and Memorandum Circular No. 2013-1 of the NDRMMC, DBM & DILG dated March 25, 2013 (Joint Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund);

WHEREAS, the Gender and Development Plan and Budget for CY 2019 of the LGU has been reviewed and approved by the Department of Interior and Local Government (DILG) Provincial Office, and found to be compliant in form and in content with the provisions of the Joint Memorandum Circular No. 2016-01 entitled "Amendments to JMC 2013-01 or the Guidelines on the Localization of Magna Carta of Women";
