APPROVING RESOLUTION NO. 251, S-2020 OF THE SANGGUNIANG BAYAN OF STA. BARBARA, PANGASINAN, ENTITLED "CONCURRING/APPROVING MUNICIPAL DEVELOPMENT COUNCIL (MDC) RESOLUTION NO. 2020-13, SERIES OF 2020 ENTITLED "ADOPTION OF RESOLUTION ENDORSING THE REVISED ANNUAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF STA. BARBARA, PANGASINAN CALENDAR YEAR 2020 AND ENDORSING IT TO THE SANGGUNIANG BAYAN FOR APPROVAL"

WHEREAS, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its Resolution No. 251, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council of Sta. Barbara, Pangasinan endorsed to the Sangguniang Bayan for approval the Revised Annual Investment Program (AIP) for CY 2020. This was endorsed by the Council to the Sangguniang Bayan through MDC Resolution No. 2020-13, S-2020;

WHEREAS, the 2020 AIP of Sta. Barbara, Pangasinan was revised to include additional projects and activities under the Revised LDRRMFI Plan which is the subject of SB Resolution No. 250, S-2020;

WHEREAS, the additional projects and activities to include COVID-19 related PPAs will be funded from the LGU's LDRRMF Unexpended Balances from CYs 2016 to 2019;




