APPROVING RESOLUTION NO. 2021-61 OF THE SANGGUNIANG BAYAN OF BOLINAO, PANGASINAN, ENTITLED "TO ADOPT THE DETAILS OF THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 5 CY 2021, AS EMBODIED IN THE MDC RESOLUTION NUMBER 7, SERIES OF 2021 OF THE MUNICIPAL DEVELOPMENT COUNCIL OF BOLINAO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Bolinao Pangasinan submitted its SB Resolution No. 2021-61 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R.A. 7160;

WHEREAS, the Local Development Council of Bolinao, Pangasinan had identified items in their Supplemental Investment Program No. 5 for CY 2021. This was endorsed to the Sangguniang Bayan for approval on October 26, 2021 by the MDC through Resolution No. 7, S-2021;

WHEREAS, the Supplemental Investment Program covers fund augmentation for the Personal Services of some municipal office and the implementation of COVID-19 related activities, gender and development programs, disaster risk reduction projects and other priority programs of the municipality;




