RESOLUTION NO. 1045-2021

DECLARING THE SUPPLEMENTAL BUDGET NO. 5 FOR CALENDAR YEAR 2021 OF BOLINA0, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P10,150,000.00, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Bolinao, Pangasinan submitted its Supplemental Budget No. 5 for Calendar Year 2021 involving total appropriations of P10,150,000.00, which was enacted on November 4, 2021 through Appropriation Ordinance No. 2021-05;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. 9184 (The Government Procurement Reform Act) and its Revised Implementing Rules and Regulations; and

That all programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2021 Supplemental Investment Program of the municipality formulated pursuant to DILG NEDA-DBM-DOF- Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007 and DILG-DBM Joint Memorandum Circular No. 01 dated 27 March 2020.


WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;


