APPROVING RESOLUTION NO. 84, S-2020 OF THE SANGGUNIANG BAYAN OF STO. TOMAS, PANGASINAN, ENTITLED "APPROVING/ADOPTING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 04 (SIP-4-SS-2020) OF THE MUNICIPALITY OF STO. TOMAS, PANGASINAN FOR CALENDAR YEAR 2020"

WHEREAS, the Sangguniang Bayan of Sto. Tomas, Pangasinan submitted its Resolution No. 84, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Sto. Tomas, Pangasinan has formulated and endorsed the municipality's Supplemental Investment Program No. 4 thru MDC Resolution No. 04-SS-2020 dated September 29, 2020 to the Sangguniang Bayan for approval. This was approved by their Sangguniang Bayan on October 20, 2020 thru Resolution No.84, S-2020;

WHEREAS, the said Supplemental Investment Program No. 4 with an investment requirement of P4,483,773.29 covers the implementation of salary increase, and other personnel benefits of municipal officials and employees;
