APPROVING RESOLUTION NO. 266, S-2020 OF THE SANGGUNIANG BAYAN OF BAUTISTA, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF BAUTISTA, PROVINCE OF PANGASINAN UNDER MDC RESOLUTION NO. 11, SERIES OF 2020 TO BE FUNDED FROM THE SUPPLEMENTAL BUDGET NO. 5 CY 2020 AMOUNTING TO SEVEN HUNDRED EIGHTY THOUSAND PESOS (P780,000.00)"

WHEREAS, the Sangguniang Bayan of Bautista, Pangasinan submitted its Resolution No. 266, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Bautista, Pangasinan has formulated the municipality's Supplemental Investment Program No. 7 and endorsed thru MDC Resolution No. 11, S-2020 dated December 22, 2020 to the Sangguniang Bayan for approval;

WHEREAS, the Supplemental Investment Program No. 7 with an investment requirement of P780,000.00 covers the provision of Service Recognition Incentive benefits for municipal officials and employees;

WHEREAS, the Sangguniang Bayan on December 22, 2020 enacted Supplemental Budget No. 5 thru Appropriation Ordinance No. 6, S-2020 to support the implementation of the Supplemental Investment Program of the municipality;


