PROVINCIAL RESOLUTION NO. 1053-2020

AUTHORIZING THE GRANT OF FINANCIAL ASSISTANCE TO THE CALAMITY VICTIMS CAUSED BY TYPHOON “ROLLY” IN THE PROVINCES OF ALBAY AND CATANDUANES, BOTH LOCATED IN THE BICOL REGION OF LUZON

WHEREAS, the Sangguniang Panlalawigan is in receipt of Provincial Disaster Risk Reduction and Management Council (PDRRMC) Resolution No. 7, S-2020, dated November 4, 2020, “Extending Financial Assistance in the Total Amount of Two Million Pesos (P2,000,000.00)-One Million Pesos (P1,000,000.00) Each to the Provinces of Albay and Catanduanes due to Super Typhoon “Rolly”;

WHEREAS, in November 1, 2020, Typhoon “Rolly”, considered as the world’s most powerful typhoon in 2020, devastated the country’s Bicol Region in Luzon specifically the Provinces of Albay and Catanduanes;

WHEREAS, Typhoon “Rolly” battered parts of that areas with destructive winds and torrential rain causing billions worth of damages to infrastructure, agriculture and school buildings including the loss of lives;

WHEREAS, the Provincial Government of Pangasinan has decided to extend a financial assistance in the amount of One Million (P1,000,000.00) each to the beleaguered areas of the Provinces of Albay and Catanduanes;

WHEREAS, the above-significant humanitarian endeavor of the Provincial Government of Pangasinan will greatly benefit thousands of families in the areas that were affected by the onslaught of Typhoon “Rolly”;


