PROVINCIAL RESOLUTION NO. 1055-2020

EXTENDING THE DEADLINE FOR THE PAYMENT OF TAXES, FEES AND CHARGES IMPOSED AND COLLECTED BY THE PROVINCE ON OR AFTER SEPTEMBER 14, 2020 UNTIL DECEMBER 19, 2020 AND THE NON-APPLICATION OF INTEREST, SURCHARGE AND OTHER PENALTY DURING THE PERIOD

WHEREAS, Section 4 (tt) of RA 11494, otherwise known as the “Bayanihan to Recover as One Act” provides for the moving of statutory deadlines and timelines for the filing and submission of any document, the payment of taxes, fees, and other charges required by law, and the grant of any benefit in order to ease the burden on individuals under community quarantine;

WHEREAS, Department Circular No. 003-2020 of the Department of Finance provides for the guidelines for the uniform implementation by the local government units of the above provision of law;

WHEREAS, Section 3 of said Circular which mandates the payment of all local taxes, fees and charges with statutory deadlines, duly authorized and imposed by local government units within their respective territorial jurisdictions, that fall on or after 14 September 2020 shall be extended under 19 December 2020. The counting of the period within which to pay local taxes, fees and charges shall likewise be suspended until 19 December 2020, including the period for the redemption of real properties sold or forfeited at public auction;

WHEREAS, the Sangguniang Panlalawigan finds it meritorious and proper to implement the said DOF Department Circular in order to lighten the plight of every concerned individual during this period of public health crisis, in accordance with a duly mandated set of guidelines;

WHEREFORE, in view of the foregoing, on motion of SP Member Angel M. Baniqued, Jr., duly seconded, it was –


