RESOLUTION NO. 1055-2021

DECLARING ORDINANCE NO. 25, S-2021 OF THE SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN, ENTITLED “AN ORDINANCE CREATING THE POSITION OF ONE (1) ADMINISTRATIVE AIDE III (DRIVER I), SALARY GRADE 3 OF THE MUNICIPALITY OF ASINGAN, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its Ordinance No. 25, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 76 and Section 447 (a) (1) (viii) of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Salvador S. Perez, Jr. and Noel C. Bince and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 25, S-2021 of the Sangguniang Bayan of Asingan, Pangasinan, entitled “An Ordinance creating the position of one (1) Administrative Aide III (Driver I), Salary Grade 3 of the Municipality of Asingan, Pangasinan” as within the conferred powers of the Sangguniang Bayan to enact;






