RESOLUTION NO. 106-2019

DECLARING MUNICIPAL ORDINANCE NO. 2018-10 OF THE SANGGUNIANG BAYAN OF ALCALA, PANGASINAN, ENTITLED “AN ORDINANCE ESTABLISHING A PEOPLE’S LAW ENFORCEMENT BOARD (PLEB) IN THE MUNICIPALITY OF ALCALA, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Alcala, Pangasinan submitted its Municipal Ordinance No. 2018-10 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 43 of RA No. 6975 or “An Act Establishing the Philippine National Police Under a Reorganized Department of the Interior and Local Government, and For Other Purposes, As Amended” and Article 63 (f) of Administrative Order No. 270 – Prescribing the Implementing Rules and Regulations of the Local Government Code of 1991;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject municipal ordinance in order;


