**APPROVING RESOLUTION NO. 2020-234 OF THE SANGGUNIANG BAYAN OF STA. BARBARA, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 4 OF THE MUNICIPAL GOVERNMENT OF STA. BARBARA, PANGASINAN FOR CALENDAR YEAR 2020, REQUIRING A TOTAL FUNDING OF ELEVEN MILLION NINE HUNDRED TWENTY THREE THOUSAND EIGHT HUNDRED NINETY SEVEN PESOS (P11,923,897.00)”**

**WHEREAS**, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its Resolution No. 2020-234 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council of Sta. Barbara has prepared the Supplemental Annual Investment Program (AIP) No. 4 for CY 2020. This was endorsed by the Council, through MDC Resolution No. 2020-04, S-2020 dated October 13, 2020 to the Sangguniang Bayan for approval. The Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 2020-234, S-2020 dated October 26, 2020;

**WHEREAS**, the Supplemental AIP which has a total investment requirement of P11,923,897.00 covers augmentation funds for PS, MOOE and Capital Outlay of some offices of the municipality, and COVID-19 related projects;
