APPROVING MUNICIPAL RESOLUTION NO. 2019-120 OF THE SANGGUNIANG BAYAN OF ALCALA, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 03 FOR CALENDAR YEAR 2019 OF THE MUNICIPALITY OF ALCALA, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of Alcala, Pangasinan submitted its Municipal Resolution No. 2019-120 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Alcala, Pangasinan has formulated the municipality's Supplemental Investment Program No. 3 for Calendar Year 2019 and endorsed to the Sangguniang Bayan for approval thru MDC Executive Committee Resolution No. 2019-02 dated November 29, 2019. The Sangguniang Bayan approved the Supplemental Investment Program No. 3 on December 2, 2019 thru Resolution No. 2019-120. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Supplemental Investment Program No. 3 of the municipality with an investment requirement of P4,439,378.96 covers the fund augmentation for the Personal Services, Maintenance and Other Operating Expenses and disaster risk reduction management programs and implementation of social services projects of offices in the municipality;
