RESOLUTION NO. 107-2022

**DECLARING THE SUPPLEMENTAL BUDGET NO. 2 FOR
CALENDAR YEAR 2021 OF MANAOAG, PANGASINAN
INVOLVING A TOTAL APPROPRIATION OF
P37,560,201.66, OPERATIVE IN ITS ENTIRETY**

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Manaoag, Pangasinan submitted its Supplemental Budget No. 2 for Calendar Year 2021 involving total appropriations of P37,560,201.66, which was enacted on December 14, 2021 through Appropriation Ordinance No. 03, Series of 2021;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. That the funding sources for the subject Supplemental Budget was determined in accordance with Section 321 of R.A. No. 7160 and Article 417 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;

2. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2021 Supplemental Investment Program of the municipality formulated to pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1 Series of 2007 dated March 8, 2007;
3. That all procurement to be undertaken shall strictly be subject to the pertinent provisions of R.A. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations;
4. That the implementation of projects funded by the share from Tobacco Excise tax shall be in accordance with the provisions of the Local budget memorandum Nos. 83 & 84; and
5. That the appropriation for honoraria of BAC Members shall be in accordance with the provisions of Budget Circular No. 2004-5A and 2007-3.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Jeremy Agerico B. Rosario and Liberato Z. Villegas and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety the Supplemental Budget No. 2 for Calendar Year 2021 of Manaoag, Pangasinan;
