APPROVING RESOLUTION NO. 21-128 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED "A RESOLUTION APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 8 FOR CALENDAR YEAR 2021 OF THE CITY OF SAN CARLOS, PROVINCE OF PANGASINAN"

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its SP Resolution No. 21-128 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R.A. 7160;

WHEREAS, the City Development Council-Executive Committee of San Carlos City, Pangasinan prepared the city's Supplemental Annual Investment Program No. 8 for CY 2021. This was endorsed by the Council through CDC Resolution No. 11-21 dated October 1, 2021;

WHEREAS, the said Supplemental Investment Program which has a total investment requirement of P24,069,888.00 covers the augmentation fund for Personal Services, MOOE and Capital Outlay, and implementation of development projects of the city;

This is embodied in the LGU's Supplemental Budget No. 05-21, FY 2021 which was approved by the Sangguniang Panlungsod through Appropriation Ordinance No. 21-13 dated October 11, 2021;
