AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO EXECUTE A DEED OF DONATION IN FAVOR OF THE PHILIPPINE NATIONAL POLICE (PNP), PANGASINAN POLICE CRIME LABORATORY OFFICE OVER A PARCEL OF LAND CONTAINING AN AREA OF APPROXIMATELY ONE HUNDRED SIXTY (160) SQUARE METERS AT CAMP ANTONIO U. SISON, LINGAYEN, PANGASINAN FOR THE LOCATION OF ITS NEWLY-CONSTRUCTED PNP CRIME LABORATORY BUILDING

WHEREAS, the Philippine National Police (PNP), Pangasinan Police Crime Laboratory Office has requested the Province that it be allocated with a parcel of land for the construction of its PNP Crime Laboratory Building;


